

# Ukulima Sacco Website Cookie Policy

UKULIMA SACCO is committed to keep your personally identifiable and financial information confidential and secure.

Through our website, we strive to provide important and up to date information regarding our products and services. This includes information about our SACCO products such as: accounts, loans, ATM cards, business solutions, Membership Registration and extended services (online & mobile banking, mobile applications, Smart ATM services etc.) in addition to our branch locations, hours of operation, and how to contact us.

This website cookie policy explains how we collect and use information you provide through your interaction with the UKULIMA SACCO website and for advertising purposes.

## Site usage and Cookies Policy

When you visit our website, we may collect and store information about your visit on an anonymous, aggregate basis and use it for internal review purposes only.

UKULIMA SACCO may use the information we collect to analyze and track data, determine what content is most popular, and measure the number of visitors to different sections of our website. This information will assist us in making our website more useful to consumers based on their interests. The anonymous information about your visits may be collected by using various technologies, such as cookies. Cookies are *small text files placed on your computer or other devices you may be using, such as a tablet or smartphone when you visit a website*. The cookie is a randomly generated 18-digit ID number that uniquely identifies a web browser on a specific computer, but is not used to identify an individual person. Cookies allow a website to recognize a particular device or browser and remember information about that device's preferences when visiting the website again.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can modify your browser setting to decline cookies if you prefer. If you block all cookies, you may find that certain features on our website will not work properly.

## WHAT ARE COOKIES?

Cookies are files that are likely to be saved on your device when you visit a website. Cookies allow a website to recognize the device in which it is registered in order to bring you an additional service: improved surfing experience, connection security or even adaptation of the content of a page to your areas of interest. The information stored by cookies, for a limited duration, include the pages visited, ads on which you have clicked, the type of browser you use, your IP address, as well as information entered so you do not need to re-enter again.

The device means any hardware (computer, tablet, smartphone) you use to view or to see a website, application, advertising content, etc.
